TWENTY-FIFTH ORDER CONCERNING OPERATIONS  
OF THE DISTRICT COURT OF THE VIRGIN ISLANDS  
DURING THE COVID-19 OUTBREAK**

The District Court of the Virgin Islands continues to monitor the outbreak of the Coronavirus Disease 2019 (COVID-19). In so doing, the Honorable Robert A. Molloy, Chief Judge, issued the Twenty-Fifth Order Concerning Operations of the District Court of the Virgin Islands During COVID-19 Outbreak on Thursday, July 29, 2021.

This Order will take effect on August 1, 2021 and will remain in effect through August 31, 2021, unless modified or terminated earlier or extended by further Order of the Court. The District Court of the Virgin Islands will remain open; however, in-person counter services will be suspended until further notice. Filings will continue to be received via the Court's electronic case management system, CM/ECF, and reviewed and monitored in due course.
