**NOTICE OF OPERATIONS OF THE DISTRICT COURT OF THE VIRGIN ISLANDS
DURING THE WEEK OF DECEMBER 28, 2021 THROUGH DECEMBER 31, 2021
IN RESPONSE TO THE RISE IN COVID 19 OUTBREAK**

The District Court of the Virgin Islands continues to monitor the outbreak of the Coronavirus Disease 2019 (COVID-19). In so doing, the Honorable Robert A. Molloy, Chief Judge, has advised due to the rise in COVID-19 Outbreak positivity rate, the District Court of the Virgin Islands will be closed to in-person service from December 28, 2021 through December 31, 2021.

The District Court of the Virgin Islands will remain open; however, Court personnel will be working remotely. Filings will continue to be received via the Court's electronic case management system, CM/ECF, and reviewed and monitored in due course.
