During her tenure with the District Court, Ms. Arroyo's responsibilities have included work in a variety of areas, including human resources, financial services, continuity of operations planning, docketing and docket management, jury management, courtroom deputy functions, facility management and statistical reporting. She has made notable contributions over the years to the efficiency and effectiveness of court operations, and was particularly instrumental in the development of the first Continuity of Operations Plan (COOP); the implementation of the Human Resources Information Management System (HRMIS); the coordination of the Court's recovery

efforts—aimed at both the physical plant and court operations—after hurricanes Irma and Maria; and in her lead role during the Court's preparation for the implementation of CM ASSIST—an enhanced data quality control tool. In addition, Ms. Arroyo is well known for her excellent support and customer service and has developed positive working relationships both within the Court and externally.

A native of St. Croix, Ms. Arroyo earned an Associates of Arts in Business Administration from AXIA College of Western International University in 2006, and a Bachelors in Business Administration (Human Resources) and a Master of Business Administration (Finance) from Colorado Technical University in 2007 and 2009, respectively.
