**DISTRICT COURT OF THE VIRGIN ISLANDS TO HOST FREE PUBLIC EVENT
FEATURING 83rd UNITED STATES ATTORNEY GENERAL LORETTA E. LYNCH**

The Honorable Wilma A. Lewis, Chief Judge of the District Court, invites the general public to “*An Evening with Loretta E. Lynch, 83rd Attorney General of the United States*” on Tuesday, February 25, 2020 at 6:30 p.m., at the Almeric L. Christian Federal Building and Courthouse on St. Croix. There is no admission fee to attend.

Ms. Lynch was the first African-American female Attorney General of the United States in U.S. history. Confirmed by the U.S. Senate on April 23, 2015, Ms. Lynch served as Attorney General until January 20, 2017. Prior thereto, Ms. Lynch served on two occasions as the U.S. Attorney for the Eastern District of New York, from 1999 to 2001 and from 2010 to 2015, respectively, and in private practice as a partner with Hogan and Hartson (now Hogan Lovells) from 2001 to 2010. Ms. Lynch is currently a litigation partner with the law firm of Paul Weiss Rifkind Wharton & Garrison in New York.
