**DISTRICT COURT OF THE VIRGIN ISLANDS TO HOST FREE PUBLIC EVENT
FEATURING 83rd UNITED STATES ATTORNEY GENERAL LORETTA E. LYNCH**

The general public is reminded about the fast approaching February 17, 2020 registration deadline for a free public event featuring the 83rd United States Attorney General Loretta E. Lynch. If you have already registered and have not received a confirmation from the Court, please contact the Clerk's Office at 340-718-1130 (St. Croix) or 340-774-0640 (St. Thomas).

Ms. Lynch was the first African-American female Attorney General of the United States in U.S. history. Confirmed by the U.S. Senate on April 23, 2015, Ms. Lynch served as Attorney General until January 20, 2017. Prior thereto, Ms. Lynch served on two occasions as the U.S. Attorney for the Eastern District of New York, from 1999 to 2001 and from 2010 to 2015, respectively, and in private practice as a partner with Hogan and Hartson (now Hogan Lovells) from 2001 to 2010. Ms. Lynch is currently a litigation partner with the law firm of Paul Weiss Rifkind Wharton & Garrison in New York.
