

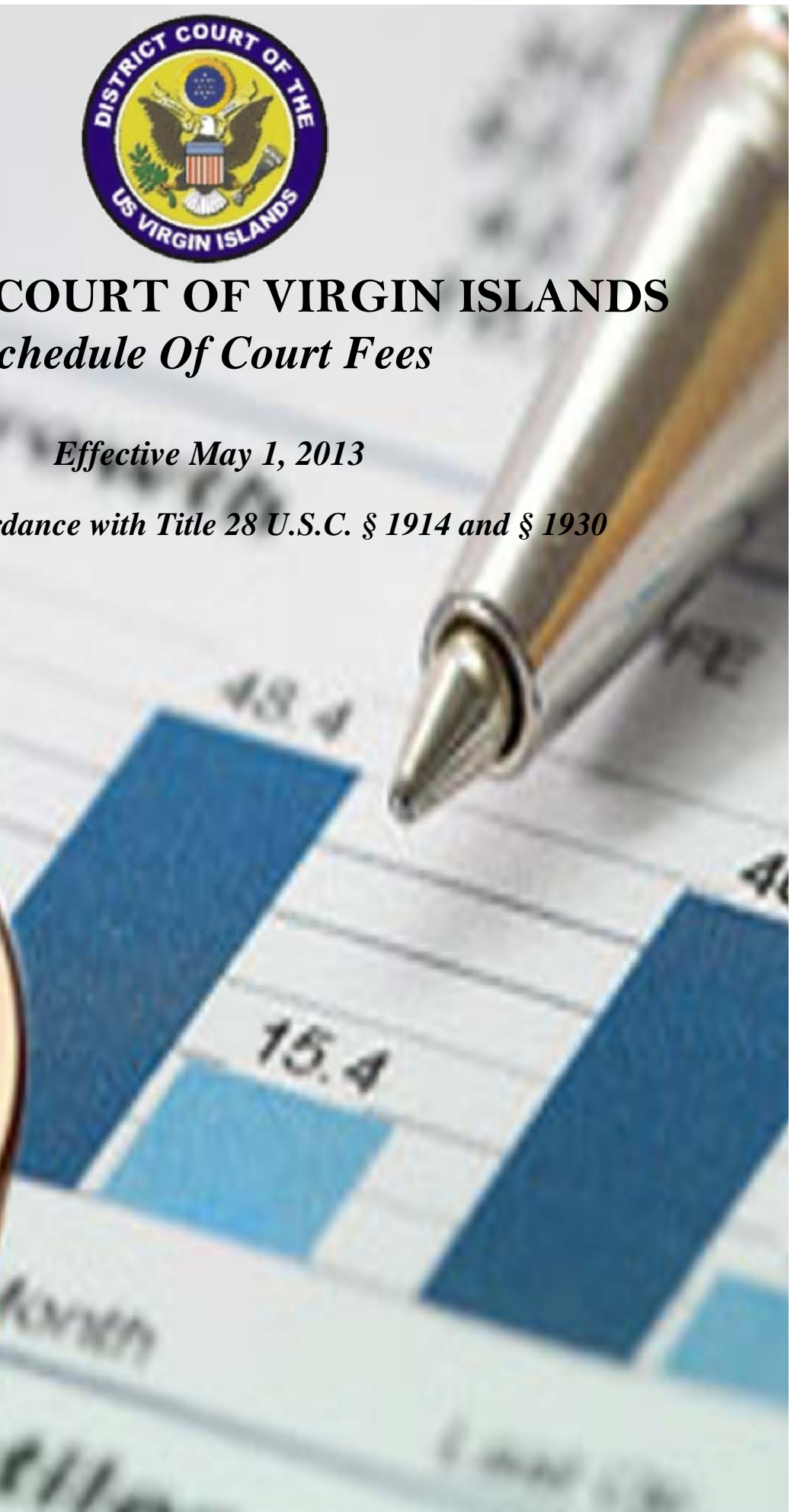

The fee for printing copies of any record or document accessed electronically at a public terminal (\$0.10 per page) does not apply to services rendered on behalf of the United States if the record requested is not remotely available through electronic access. The fee for local, state, and federal government entities, shall be \$0.08 per page until April 1, 2015, after which time, the fee shall be \$0.10 per page.)	\$0.10
