SECOND ORDER CONCERNING OPERATIONS OF THE
DISTRICT COURT OF THE VIRGIN ISLANDS
DURING THE COVID-19 OUTBREAK**

The Honorable Wilma A. Lewis, Chief Judge of the District Court of the Virgin Islands hereby advises the public that the District Court of the Virgin Islands has moved into the second phase of its response to the COVID-19 pandemic.

Effective Monday, March 23, 2020, the District Court of the Virgin Islands will remain open; however, Court personnel will be working remotely. Filings will continue to be received via the Court's electronic case management system, CM/ECF, and reviewed and monitored in due course.
